The reply shall be preferentially sent by the same means used by the Data Subject when requesting to exercise its rights.

The request may be exercised free of charge; however, in the event of manifestly unfounded or excessive (even repetitive) requests, the data subjects will be notified in advance of the fee at their charge and asked for confirmation before proceeding.

Merlo S.p.A. undertakes to reply within 30 days from receipt of this completed form. This deadline may be extended by two months if necessary, taking into account the complexity and number of requests. The Data Controller shall inform the Data Subject of this extension, and of the reasons for the delay, within one month of receipt of the request.

If the form is not presented in person and hence direct identification is not possible, a copy of the identification document must to be enclosed and will be kept in the records with a specific wording (such as: "this document was acquired by Merlo S.p.A. together with the form to exercise the Data Subject's rights submitted on").

Art. 15 – Access to personal data

The undersigned hereby asks for your confirmation as to whether or not personal data concerning him/her are being processed
